
Rory Riggs and The Evolution of Indexing

An early believer in index investing, Rory Riggs also thought that there had to be a more efficient way to passively capture market returns than either conventional cap or equal weighting and set out to uncover it.

As a co-founder of Royalty Pharma, Rory's experience with healthcare inspired the solution – specifically the use of sampling and stratification to control for biases in clinical trial results. He and his team developed and patented FIS technology - a new way of categorizing companies using a methodology called "related business risk". Simply put, related business risk is the risk that one or more companies' earnings are affected by the same economic drivers.

Classifying and then equally weighting companies by related business risk enables Stratified ETFs to help avoid being over-exposed to any specific industry sector. It also creates a more diversified exposure to the performance of the underlying businesses within a sector.

The Result: Seeks improved exposure to the market equity risk premium
