



The Fund seeks to provide investment results that, before expenses, track the performance of the Syntax Stratified SmallCap Index. Using the Stratified Weight methodology, the fund re-weights and rebalances the stocks contained in the S&P 600 index. Compared to capitalization weighted indexes, the Stratified approach may provide investors with the following potential advantages:

Reduce the negative impact of a significant correction in an overweight sector

Increase the chance of participating in all sectors during a market rally

Capture a fuller range of market opportunities
